

# NOTICE PUBLIC HEARING FEBRUARY 28, 2012

The Loudoun County Sanitation Authority (Loudoun Water) has adopted a resolution signifying its intent to change certain rates, fees and charges applicable to the following wastewater systems: Waterford, St. Louis, Aldie and Willisville.

## Preliminary Schedule of Rates to be effective April 1, 2012

### Wastewater

**Waterford Community System:** Customers served by the Waterford wastewater treatment plant will be billed a flat monthly rate based on 5,500 gallons. In addition to a basic charge, the charge for wastewater continuing services shall be billed as follows:

\$36.42 *	\$50.05 **	\$75.35 **

\* same as 2011 rate

\*\* equal to average community system rate

St. Louis, Aldie and Willisville Community Systems: Customers served by the **St. Louis, Aldie and Willisville** wastewater treatment plants will be billed a flat monthly rate based on 5,500 gallons. In addition to a basic charge, the charge for wastewater continuing services shall be billed as follows:

The single service charge, currently \$3.50, will not apply to non-metered, sewer only customers.

**ALL OTHER RATES, FEES AND CHARGES CURRENTLY IN FORCE WILL REMAIN UNCHANGED.**

A public hearing on the foregoing will be held on **February 28, 2012 at 6:00 p.m. at Loudoun Water's Administration Office at 44865 Loudoun Water Way, Ashburn, VA** (to be rescheduled to March 6, 2012, 6:00 p.m. in the event the hearing is canceled due to inclement weather or any other reason). At its March 8, 2012 Board meeting, the Loudoun Water Board of Directors will consider approval of final rates, fees and charges with changes adopted by the Board effective April 1, 2012.
